




**Graph 1. Real GDP and inflation (%)**




**Graph 2. Budget balance Gen.Govt.**




**Graph 3. Government debt**




**Graph 4. Monetary financing (mln. NAf.)**




**Graph 5. Balance of payments (mln. NAf.)**




**Graph 6. Export and import of goods & services (mln. NAf.)**




**Graph 7. Money supply (mln. NAf.)**
