False Promissory Notes from Venezuela Warning Notice - Circular - Advisory Issue No 5- April 2004

These Warnings contain the names of entities/persons and/or associates <u>recently</u> brought to BNA's attention through some form of notice, inquiry or complaint. If these entities and/or associates are operating in/or out of the Netherlands Antilles, they may be violating <u>provisions</u> of the <u>Supervision</u>
Act or other financial regulation, thereby affecting the integrity of the financial sector.

Case Description

This scam alert refers to the latest public warning by the Ministry of Finance of Venezuela against the acceptance of false promissory notes abroad - "NOTAS PROMISORIAS" Codigo CARONI, ICC-290 e ICC-322 — supposedly issued by the extincted Banco de Desarrollo Agropecuario (BANDARAGO).

As stated in a former notice by the Ministry of Finance on February 23, 2001, these promissory notes have never been issued by the Banco de Desarrollo Agropecuario and therefore are of no value whatsoever as a credit document for the Venezuelan state.
